In the event that the health and/or well-being of the reserved puppy described above is hindered in any manner due to any act of God, outside of our control, the Buyer will be offered a puppy of choice from this or any other future litter, refund of deposit and/or any other payments that have been made at that time may be offered in lieu of a replacement puppy at the sole discretion of Randy and Dorrie Webster. Webster's Boxers' standard policy is absolutely no refunds; any offer to refund a deposit and/or payments, for any reason, will be made at the sole discretion of the sellers, Randy and Dorrie Webster.
